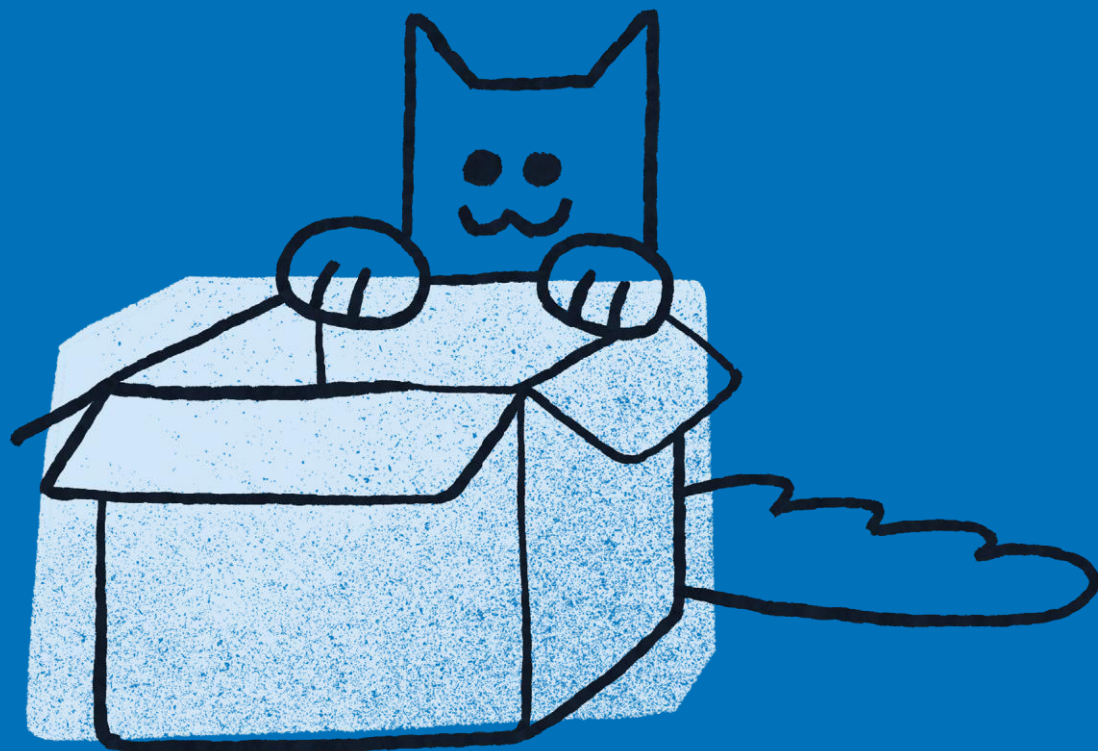

General Information

This *Postal Service Tariff Book* lists the rates for services provided by Latvijas Pasts VAS (hereinafter referred to as “Latvijas Pasts”).

The rates for letter and parcel post depend on the type of service, the weight of the item, and the destination. Postal service tariffs were approved by Decision **No. 88** of the Public Utilities Commission dated 28 November 2024.

Letter (letter correspondence containing documents) — postal items with a weight of up to 2 kg. These are postal items enclosed in an envelope or similarly packaged, used to send written communications, documents, postcards, photographs, and various types of printed materials. Item dimensions: Minimum: 14 x 9 cm. For rolls: the sum of length and double diameter must be at least 17 cm, with the longest side being at least 10 cm. Maximum: the sum of length, width and thickness must not exceed 90 cm, the longest side must not exceed 60 cm, and thickness must not exceed 2 cm. For rolls: the sum of length and double diameter must not exceed 104 cm, with the longest side being no more than 90 cm.

Small parcel (letter correspondence containing items) — postal items with a weight of up to 2 kg. Postage of small, non-fragile items. Package dimensions: Minimum: 14 x 9 cm. For rolls: the sum of length and double diameter must be at least 17 cm, with the longest side being at least 10 cm. Maximum: the sum of length, width, and thickness must not exceed 90 cm, with the longest side up to 60 cm. For rolls: the sum of length and double diameter must not exceed 104 cm, with the longest side up to 90 cm.

Parcel — postal items containing manufacturing goods, household articles, cultural commodities, foodstuffs and other items with or without commercial value.

Package dimensions: Minimum: 9 x 14 cm. Maximum: the sum of length and largest circumference must not exceed 200 cm, with the longest side up to 105 cm.

The maximum weight for a parcel is up to 20 kg for domestic post. For cross-border post, the maximum weight depends on the destination country, as specified in the International Postal Item Acceptance Manual.

For letter post, there is Tracking Service available, and for parcels weighing over 10 kg, value-added tax (hereinafter referred to as VAT) is applied. The VAT rate for these items depends on the destination of dispatch:

- For postal items sent within Latvia — 21%;
- For postal items sent to the European Union Member States — 21%;
- For postal items sent to other countries — 0%.

Unless specified otherwise, VAT is included in the indicated tariffs, which represent the final service price.

Depending on the type of service, Latvijas Pasts accepts the following items for sending:

- **Ordinary postal item** — an unregistered postal item for which no receipt is issued and which is delivered to the addressee by placing it in their postbox, if the size allows.
- **Trackable postal item** — a registered postal item that is trackable at all stages of processing and can be delivered to the customer's postbox, if the size allows.
- **Registered postal item** — a postal item for which the sender receives a receipt confirming its acceptance at the post office and which is delivered to the addressee upon receipt of a signature.
- **Insured postal item** — a registered postal item for which the sender receives a receipt confirming its acceptance at the post office and which is delivered to the addressee upon receipt of a signature. The contents of the insured postal item are covered against loss, theft or damage for a declared value.
- **Secogram** — a free of charge, ordinary letter post item weighing up to 7 kg, sent by or addressed to a blind person or an organisation representing blind individuals. The postal item may contain printed materials or articles intended for use by blind individuals, such as audio recordings, Braille-printed materials, or Braille watches.



General Information

The sender submits postal items that are properly prepared and packaged. The sender is responsible for the correct preparation and packaging of postal items. The sender ensures that items intended for shipment to a specific country are not listed among the prohibited items: https://pasts.lv/lv/privatpersonam/noderigi/aizliegts_sutit/. Correct and secure preparation of the postal item is a prerequisite for its successful delivery to the destination. The postal item must be properly packaged and sealed, with no loose ends or edges, ensuring that all contents are securely enclosed.

Compensation for Loss, Damage or Missing Contents of Postal Items

If a postal item is received damaged, and damage or shortage of its contents is identified upon delivery, the recipient may request compensation for the loss by submitting an application.

In the case of loss of a domestic postal item or damage or shortage of its contents, Latvijas Pasts will provide compensation in accordance with the procedure outlined in Cabinet Regulation No. 227 dated 09/03/2010.

Latvijas Pasts provides compensation for the loss of cross-border postal items or damage or shortage of their contents in accordance with international agreements binding on the Republic of Latvia.

Delivery of Postal Items

Postal items are delivered to recipients in Latvia once per working day.

Depending on the type of service chosen by the sender, a postal item may be delivered to the recipient's postbox, specified address, to a post office, or to Latvijas Pasts' partners upon receipt of a signature. If the recipient's postbox is damaged, the postal item cannot be placed in it, or the recipient is unreachable at the time of delivery, a Notice is left in the postbox or a text message is sent to the recipient, informing them that the postal item can be collected at a post office.

When collecting a registered or insured postal item, the recipient must present a personal identification document and the collection notice, either in text message or paper format. To collect ordinary and trackable postal items, only the collection notice, in text message or paper format, is required.

Postal items addressed to individuals under the age of 15 are handed over if the recipient presents a personal identification document or another document (e.g., student ID, pupil ID) containing the holder's photograph and personal signature (if applicable), as well as the issuing authority and validity period. Postal items may also be handed over to the legal representatives of minor recipients, provided they present a personal identification document and a document proving their legal relationship with the minor (e.g., the recipient's birth certificate, the recipient's entry in a parent's passport, or a copy of the decision appointing the person as the recipient's guardian). Authorised persons must also present a power of attorney for postal item collection. For economic operators — a personal identification document and an authorisation issued by the organisation, or another document proving the right to represent the organisation.

!!! When receiving postal items from countries outside the European Union, customs duties may apply to the postal item.

1.2. CASH-ON-DELIVERY POST

Insured domestic postal items can be sent with cash-on-delivery. The cash-on-delivery amount is determined by the sender and must not exceed the insurance amount of the respective postal item. The cash-on-delivery postal item is handed over to the recipient only after the full amount has been collected. The collected cash-on-delivery amount is transferred to the sender using the selected payment method — to the PPS account, to an account with a credit institution, or by postal remittance.

* This fee is charged in addition to the postage fee for the respective category of postal item. If the recipient of a postal item is unreachable, unwilling or unable to pay the cash-on-delivery amount, the item is considered undeliverable and is returned to the sender without refund of this fee.
